


# NOMINATIONS AND ELECTIONS



#### GUIDELINES FOR NOMINATIONS AND ELECTIONS for the 61<sup>ST</sup> SYNOD

Elections will be held for the following positions:

#### **Executive Council**

1 clerical and 2 lay delegates from each region

#### **Court of the Synod of the Diocese of Edmonton**

2 clerical and 2 lay delegates (1 to be a member of the Law Society of Alberta)

#### General Synod (to be convened in Halifax N.S. from June 3<sup>rd</sup> to 11<sup>th</sup>, 2010)

4 clerical, 4 lay delegates and 1 youth delegate

Those nominated as youth delegates to General Synod must be between the ages of 18 and 25 at the time of General Synod.

Those people nominated but not elected at this Diocesan Synod become the alternates in order of number of votes received, and would attend General Synod if any of the elected delegates cannot attend.

## Provincial Synod (Province of Rupert's Land) (to be convened in Calgary from June 12<sup>th</sup> to 14<sup>th</sup>, 2009)

4 clerical, 3 lay members and 1 youth delegate

Those nominated as youth delegates to Provincial Synod must be between the ages of 16 and 25 inclusive as of May 1, 2009.

Those people nominated but not elected at this Diocesan Synod become the alternates in order of number of votes received, and would attend Provincial Synod if any of the elected delegates cannot attend.

#### **Clerical Recorder of Synod (for the 62<sup>nd</sup> Synod)**

#### Lay Recorder of Synod (for the 62<sup>nd</sup> Synod)

Nominations will be accepted until Friday, October 3<sup>rd</sup>. There will be no nominations from the floor of Synod except with the consent of Synod. If you wish to nominate someone for any of these positions, please obtain their consent and forward their name and a short one paragraph biography to the *Rev. Michael Sung at the Synod Office no later than October 3<sup>rd</sup>*.

Please note that any persons nominated for Executive Council, Provincial Synod, General Synod, and Diocesan Court must be members of our Diocesan Synod.

Elections will be held throughout the morning on Saturday, October 18<sup>th</sup>.



# REPORT FROM THE SECRETARY OF SYNOD



#### SECRETARY OF SYNOD

I was invited to take over the voluntary position of the Secretary of Synod in February, 2005. I provide the following information as it was given to me.

The minutes of the 59<sup>th</sup> Synod (October 21- 22, 2005) and of the 60<sup>th</sup> (Electoral) Synod (March 8, 2008) were duly recorded and properly filed in the Official Minutes book of the Diocese. They are included in this circular.

Mrs. Barbara White has recorded the minutes of eighteen Diocesan Executive Council meetings since the 58<sup>th</sup> Synod. The matters related to the business transacted at these meetings have been acted upon. Following the report of the Secretary of Synod is a list of the Council's acts, rules, by-laws and resolutions undertaken or adopted since the last regular meeting of Synod.

The Diocesan Executive Council has future council meetings planned for the following dates: November 20<sup>th</sup>, 2008 and January 15<sup>th</sup>, 2009.

Should any parish corporation, clergy or diocesan committee have business they wish to have considered by the Executive Council, please feel free to contact the Bishop, Executive Officer or Regional Representative. It would be appreciated that items to be included on the Council agenda be submitted at least two weeks prior to the meeting.

#### Resolution #EC-57-05

Be it Resolved that a Diocesan Gathering be held to discuss the St. Michael Report. Carried.

#### **Resolution #EC-58-05**

Be it Resolved that the Planned Giving Policy and Guidelines be approved. Carried.

#### **Resolution #EC-59-05**

Be it Resolved that the NeighbourWorks Project Proposal be approved. Carried.

#### **Resolution #EC-61-05**

Be it Resolved that the 2006 Budget be approved. Carried with 1 vote against.

#### **Resolution #EC-06-06**

Be it Resolved that this Executive Council of the Diocese of Edmonton approve in principle the Residential Schools Amending Agreement as outlined in the confidential correspondence of January 6<sup>th</sup>, 2006, and presented in confidence at the January 19<sup>th</sup> Executive Council (Edmonton) meeting. Furthermore, we ask and authorize the Bishop and Diocesan Chancellor to confirm that they approve in Principle the Amending Agreement, on the condition it meets the requirement of section 8.1 of the Anglican Settlement Agreement (i.e. the most favoured church clause (a.k.a. the most favoured nation clause).

#### Resolution #EC-07-06

Be it Resolved that this Executive Council adopt the Privacy Policy as presented for the Synod of the Diocese of Edmonton effective March 1<sup>st</sup>, 2006; and that a communication be sent to all parishes indicating that a parish Privacy Policy is needed and that a model Privacy Policy is attached that they may use or amend but must implement by May 1<sup>st</sup>, 2006; and that parishes may ask David Connell, Diocesan Privacy Officer to act as their Privacy Officer or appoint a Privacy Officer of their own choosing no later than May 1<sup>st</sup>, 2006. Carried unanimously.

#### **Resolution #EC-10-06**

Be it Resolved that this Executive Council approves the resolution from the Administration and Finance Committee that the incumbents of the parishes of St. John the Evangelist and St. Paul's, Edmonton, currently receiving stipends in excess of the grid of the Diocese of Edmonton, shall be "grandfathered" until such time as those incumbencies become vacant. Carried with Donald Aellen abstaining.

#### Resolution #EC-11-06

Be it Resolved that this Executive Council approves the resolution from the Administration and Finance Committee that the Diocesan Stipend Grid (inclusive of housing) be amended to allow a parish to exceed the 5% stipend maximum, after having accepted its full assessment and apportionment request by the Diocese. Parishes exceeding the 5% grid maximum shall in the same calendar year contribute an amount equal to the excess over 5% to the Diocese to be used for mission ministry to be determined from time to time by the Bishop.

Parishes currently exceeding the 5% maximum may continue to pay a stipend in excess of the grid only until the specific position becomes vacant. Annual increases given for these positions shall not exceed the cost of living adjustments to the grid introduced from time to time by the Diocese. Until such time as these positions become vacant, the requirement for these parishes to contribute to the mission ministry of the Diocese shall be waived. However, if these parishes choose to pay an amount in excess of the Diocesan cost of living percentage they will be required to contribute an amount equal to that excess to mission ministry programs of the Diocese. Carried with Donald Aellen and Tom Snyder abstaining.

#### Resolution #EC-14-06

Be it Resolved that this Executive Council of the Diocese of Edmonton authorize the Bishop, Diocesan Chancellor and Archdeacons to approve the Residential Schools Amending Agreement, on the condition it meets the requirement of section 8.1 of the Anglican Settlement Agreement (i.e. the most favoured Church clause (a.k.a. the most favoured nation clause)).

Bishop Matthews assured the Executive Council members that if there were any major changes or surprises in the Amending Agreement, a special Executive Council meeting would be convened before Diocesan approval was given.

Carried.

#### Resolution #EC-15-06

That nominations cease for the position of Lay Member to Provincial Synod and that Rob Jamieson be elected by acclamation.

Carried.

#### Resolution #EC-16-06

That this Executive Council approve the resolution that the parishes of Holy Trinity, Bon Accord and Emmanuel, Gibbons become two parishes instead of one Mission.

Carried.

#### Resolution #EC-19-06

Be it Resolved by this Executive Council that the parcel of land as described above (legal description: PT SW ¼ 17, 53,21,W4) be considered for donation to a wetlands conservation organization in Strathcona County.

Carried.

#### Resolution #EC-20-06

Be it Resolved by this Executive Council that the parcel of land as described above (legal description: 32, 52, 22, W4 NE1/4 TWP RD 530) be considered for disposal through bid sale with no specified sale price.

Carried.

#### **Resolution #EC-21-06**

Be it Resolved by this Executive Council that the purchase of land between Colchester Cemetery and RR233 be pursued.

Carried.

#### Resolution #EC-24-06

Be it Resolved that this Executive Council approve the 2005 Audited Consolidated Financial Statements for the Synod of the Diocese of Edmonton. Carried.

#### **Resolution #EC-26-06**

Be it Resolved that this Executive Council give a vote of thanks to Dan Van Alstine for the work he has done as ACPO Secretary over the past few years.

Carried.

#### Resolution #EC-29-06

Be it Resolved by this Executive Council that the Clergy Stipend Schedule (including housing) be increased by 5% effective January 1<sup>st</sup>, 2007.

That Motion #EC-29-06 be amended to read approval of a 5.5% increase to the Clergy Stipend Schedule (including housing) effective January 1<sup>st</sup>, 2007.

Motion #EC-29-06 was Carried as amended.

Michael Sung abstained.

#### Resolution #EC-33-06

Be it Resolved that this Executive Council approve the Clergy/Sabbatical Study Leave Policy as presented.

Carried.

#### Resolution #EC-35-06

Be it Resolved that the Executive Council approve the Compassionate Leave Guideline. Carried.

#### Resolution #EC-39-06

Be it Resolved that this Executive Council directs that a copy of the apportionment and assessment form and the formula be circulated every year to every parish.

Carried.

#### Resolution #EC-40-06

However, if these parishes choose to pay an amount in excess of the Diocesan cost of living percentage they will be required to contribute an amount equal to that excess to mission ministry programs of the Diocese. #### ANGLICAN CHURCH WOMEN

This group, frequently referred to as A.C.W., is often the driving force behind parish functions and the first responder to traumatic events in parishioners' lives. Members bring cakes, casseroles and a shoulder to lean on rather than myrrh and frankincense. Every woman who attends an Anglican Church is part of this group.

In some parishes, amongst the women of the church, there may be an organized group who are responsible for fundraising to finance projects like supporting foster children, assisting the Dioceses of the Arctic and Yukon, local food banks and Christmas hampers. Most groups also purchase or provide funds to help purchase items for their local parish. That is all that many people see of the good works of A.C.W. and that's a shame. In fact it's akin to saying the priest only works two hours a week, one hour preparing and one hour leading the service.

During each of their meetings members donate coins which are designated Extra Cent A Day. These monies are sent in to the Diocesan Board and each year at our annual meeting a cheque is written for the Bishop's Discretionary Fund. Groups also collect Thank Offerings and these funds are divided between six charities (three within the diocese and three outside the diocese) as voted on by the membership. Our Life Members send in personal donations and these are also divided among a variety of charities according to the wishes of the Life Members group.

We all know that talent is a huge part of stewardship and ladies throughout the diocese are most generous in sharing their time and talent as in the past two years alone we provided 59 blankets, 29 comforters, 26 lap robes, 8 baby sweater sets, 6 shawls, 3 chemo-caps, 48 stuffed animals, 138 baby blankets, 812 knitted baby bonnets, 63 diaper shirts, 80 burial hoods, 58 burial gowns, 66 fabric preemie bonnets, 10 comfort dolls, 21 pair of slippers, 129 ditty bags, 37 adult toques, 47 children's toques, 12 pair handknit socks, 49 pair of gloves, 109 pair of mitts, 35 scarves, 145 toe socks and numerous toiletries to hospitals, shelters and charitable organizations. Last year we collected the equivalent of 38,162 Campbell's soup labels which helped to purchase a series of 75 books for the Belmead School in Edmonton. We also collect bags of stamps for the Bible Society. This list does not include the many donations given out at the parish level.

"Prayer and work and stewardship" is an apt description of the valuable ministry provided by Anglican Church Women. May God bless each and every one.

#### ANGLICAN MESSENGER

The Anglican Messenger is an Anglican newspaper representing the dioceses of Edmonton and Athabasca. The newspaper is available to any parish member and is accompanied through the post by the national Anglican newspaper, the Anglican Journal, from September through June.

The newspaper is not published in July and August. The *Messenger* is in good standing with the Anglican Church of Canada and belongs to the Anglican Editors' Association.

Edmonton circulation statistics are as follows:

Each year the *Anglican Journal* hosts a major fundraising drive called the "Anglican Journal Appeal" in which readers donate funds to support both the national paper and the diocesan paper. A portion of the funds raised is returned to the diocese to support publication of the *Messenger*.

Edmonton's net revenue from past appeals is as follows:

**2005** \$8,979 **2006** \$7,567 **2007** \$7,920

**2008** The appeal launches in the fall of 2008

The 2008 campaign holds the theme 'A Celebration of Commitment' in conjunction with the campaign's 15<sup>th</sup> anniversary.

From the last Synod in 2005 to spring 2008, Allison Kydd was an associate editor (Edmonton) and Roger Holmes was the managing editor. Peter Clarke was and still is currently an associate editor (Athabasca). Associate editors are responsible for finding, coordinating and/or writing news stories/features along with submitting photographs, while the managing editor formats text and photographs, in addition to designing and laying out the newspaper.

As of May 2008, Kelly Fowler took on the role as acting associate editor (Edmonton) and starting in September she will be both the Edmonton representative and the managing editor. These are volunteer positions for which Ms. Fowler receives an honorarium of \$200 per month.

With the arrival of a new bishop, the Rt. Rev. Jane Alexander, the *Messenger* has a fresh directive to 'proclaim the gospel, make disciples and further the kingdom.' The goal is to revitalize the newspaper to become both a source of information and inspiration through current, relevant stories and engaging photographs that cover all four corners of the diocese. Content should be thought-provoking and uplifting, with significance for the Edmonton diocese. As both clergy and lay people become aware of the *Messenger's* interactive abilities as a communications tool, the newspaper will continue to grow and develop over the next three years.

#### THE BISHOP'S FUND

The Bishops' Fund was started in 1951 by a group of people who wanted to give some practical help to the Anglican Bishop of the Diocese of Edmonton to aid clergy and their families. In 1971, the fund was extended to include clergy and families of the 6 parishes in the District of Mackenzie in the NWT which are part of the Diocese of the Arctic. The funds are given to the two bishops who use their discretion to aid clergy; for example, they might fly a clergy person to a relative's funeral; they might fund some counselling or stress leave; one year, one of the suffragan bishops in the Arctic was flown to the funeral of a priest and his wife who had gone through the ice and drowned. Without this fund, there is no money for these kinds of emergency. Approximately \$35,000 is raised each year.

The original founders were all men (and the organisation was known as the Bishop's Men) but for the past several years membership has been open to all—which was especially appropriate when the Bishop of Edmonton was the Rt Rev Victoria Matthews and is now the Rt Rev Jane Alexander.

The people who come to the annual dinner (which is the only fund raiser we do) are from all religious or non-religious backgrounds, men and women. The Bishop's Fund Committee pays all the expenses of the dinner, so all the members' contributions are available for the bishops' use. Each year we ask someone to speak on whatever topic they wish.

The topic of the talk is not religious in any sense at all, and the people who are asked to speak (and indeed the people who attend) are for the most part not clergy (although we did have the retired bishop of the Arctic speak one year), and are not necessarily Anglicans or church goers, or Christian, or even observant. The point of the talk is to hear from someone interesting, who has a view on some aspect of the world—which is the focal point for what is a very pleasant evening that raises money for a good cause.

Past speakers have included: last year, Chancellor Eric Newell (formerly of Syncrude), Senator Tommy Banks (who gave an eye-opener on the work that senators do); Indira Samarasekera (who was then new as President of the U of A); Jeffrey Simpson (from the Globe & Mail, who spoke just before the last provincial election, whose theme was the great opportunity for Alberta to be a leader in all sorts of things, especially education); Dr. Lorne Tyrell (a noted medical researcher and past Dean of Medicine at University of Alberta who spoke about recent medical developments); Ed Sustrik (from the Edmonton Journal, who has a long connection with the North, and talked very captivatingly about the changes that are going on up there); Bill Thorsell (then Globe & Mail, previously Edmonton Journal and the University of Alberta who talked in part about the future of Edmonton); Peter Gzoswski (CBC Radio, who just talked, and was captivating); Martha Piper (then VP Research at U of A, later President of UBC, who spoke about "hotspots" in academic and research excellence at the University of Alberta and in Edmonton), Matthew Barrett (formerly Bank of Montreal, who spoke about Canada and business, when the Bank held its annual meeting in Edmonton one year), and Jim Dinning (after he had returned to the private sector).

This year the dinner will be held on Wednesday 12 November 2008 at the Royal Mayfair. Our speaker will be Jay Ingram, the well known Canadian author and broadcaster. He has been host

of the television show *Daily Planet*, which airs on Discovery Channel Canada and he hosted the science program *Quirks and Quarks* on CBC Radio One from 1979 to 1991.

Summer fun outside the city! News flash: the Diocese sponsors several one week camps every year. Youth from across the Diocese leave the paved byways and enjoy sun fun in the forest. It is always sunny at camp, both weather and dispositions.

As I write this, preparations are gearing up for CCA Junior and Intermediate to be held at Camp Van Es. And 15 junior high students completed a week at Cold Lake Provincial Park (Base Camp) about two weeks ago, and had a wonderful time, doing some sailing, canoeing, kayaking, and playing. Camps are small communities, where children and staff live and learn the teachings of Christ. The volunteers who give up their time, whether they be priest or cook, counselor or bus driver, are the foundation of this ministry.

I would like to thank the downtown Rotary Club for donations that saw our canoeing fleet renewed. Thanks also go out to: CIBC Wood Gundy Miracle Fund, the Richard Gordon Utas Fund, Anglican Church Women's gatherings across the diocese, and individuals for donations for scholarships. In 2007, 16 campers benefited from this generosity, assisted through the Kevin Campbell Scholarship Fund.

Ongoing challenges include letting the wider church know about the work that we do, as we have an open heart and capacity to include more campers and more volunteers. In 2006 and 2007, our senior high school canoeing camp was cancelled due to lack of registrants. The camping program has also offered a weekend winter camp for the past several years, but registrations have been few. We will be re-examining our goals and objectives in the upcoming year.

Since the last Synod, I would like to thank our Bishops, Victoria and now Jane, for advice, interest and support. Thanks also go to the current members of the Camping Committee (who oversee the program), and to Laurel Franks and Dan Helm – who have stepped down, after many years of faithful service on the Committee.

Educational Chaplaincy's annual Dinner and Silent Auction, which occurs at the end of the academic year, continues to be a highlight of the year for many supporters. I wish to thank those individuals and parishes whose contributions and attendance has made this event overwhelmingly successful.

I am grateful for the Educational Chaplaincy board that have volunteered diligently, especially in the past few years during transition; consequently, their commitment and encouragement has been instrumental in the continuing support for this vital ministry. While many individuals and parishes support this ministry, a special thanks is given to Dr. Mark Peppler and his wife Ronnene, who have opened their home to students once a week, providing dinner, and a much needed, sense of community.

## COLLEGE OF EMMANUEL AND ST. CHAD

In its second term of the 2007-08 academic year, the College of Emmanuel and St Chad has 18 full-time and part-time students enrolled in courses and programs. We are anticipating five new students in the fall term of 2008. As well there are 70 students pursuing the Diploma in Indigenous Anglican Theology through our collaboration with the Dr William Winter School for Ministry in Kingfisher Lake, Ontario, nineteen of whom graduated this spring. In the past three years, the College has taught over 100 students in summer school courses, regular term courses, and its collaborative programs, as well as the many students we teach in our courses through our participation with Lutheran Theological Seminary and St Andrew's College. Our students have included Anglicans from the Dioceses of Edmonton, Calgary, Athabasca, Saskatchewan, Saskatoon, Qu'Appelle, Brandon, and Keewatin, as well as Roman Catholics and Mennonites.

A major initiative has been building up our summer offerings. We have been offering more courses in Saskatoon in May, June, and July, as well as offering courses in Calgary. Low enrolment caused our summer 2008 offering for clergy and lay people of a course in Stewardship for Leaders of Small Congregations, to be deferred until January 2009. The course leaders will be The Rev'd Dr Stephen Hopkins, from the Diocese of Niagara, who is probably the finest and most experienced congregational development consultant in the Canadian Anglican Church, and The Ven Rob Hardwick of the Diocese of Qu'Appelle, who brings his experience in working at stewardship in his own prairie context in Swift Current and around his diocese.

Over the past three years the College has made several decisions which have led to greater financial stability, and considerably enhanced our partnership and relationships with the other Colleges of the Saskatoon Theological Union. Our move into the Lutheran Seminary and the subsequent sale of our century-old buildings to the University of Saskatchewan has enhanced our work in several ways: by bringing our faculty and administrative staff into a more effective working configuration; by enabling much more regular shared worship with our full-communion Lutheran partners; by bringing our students into daily contact with the greater part of the students of the colleges here; by enabling more contact and collaboration between our two respective faculties; and by considerably enhancing our endowments.

# Key Goals and Objectives

1) Program Development and Student Recruitment—We are becoming increasingly aware through feedback in international Anglican circles that our new four year program with a backbone seminar focused on the Great Books of the Christian and Anglican tradition is the envy of many much larger seminaries across the continent. They affirm that we are one of the first seminaries to look seriously at what sort of preparation will truly be required to prepare people for ministry and outreach in the North American world of the future rather than the past. At the same time, there are very few postulants being generated in any of the prairie dioceses. Our objectives in the area of recruitment include: piloting in cooperation with the Diocese of Saskatoon an Anglican version of a program, It's Your Call, which has been extremely successful in the Lutheran Church; and, developing an exciting public campaign inviting young people to consider priesthood as a vocation. We are also exploring the possibility of a series of very short video clips that could be put on Utube to attract the attention of younger people.

2) Increasing Financial Stability—Gifts to the College's operating fund have grown by over \$100,000 a year since 2004, a rise of nearly 70%. In this regard we are probably doing as well or better on the development front than most of the theological colleges in Canada. People and parishes in every diocese in the Province of Rupert's Land are deeply committed to the College and its future. We have also for the past three years been asking parishes to implement a paradigm of giving 1-2% of their total annual donations to theological education somewhere in the Ecclesiastical Province, and many parishes are responding positively. We also believe that it is important that Dioceses continue to share a modest part of the commitment to maintain the work of theological education and the Provincial Theological College—training leaders for the future is a part of the life and mission of the church that is not simply about benefit in the here and now, but for our children and grandchildren. We worship a God who promises to keep faith with those who are faithful to the thousands of generations.

The College of Emmanuel and St Chad thanks you as individuals, as parishes, and as a diocese, for your prayers and financial support for our part of the Church's work of Growing People in Christ. Your support is essential if we are to maintain our share in this partnership as we have continued to do for the past 129 years.

## **CURSILLO MOVEMENT**

Welcoming new Cursillistas into the Edmonton Community to further God's kingdom is a blessing. In the fall of 2005 we were privileged to welcome 12 men and 22 women. 13 men and 24 women joined our membership in the fall of 2006. After prayerful consideration Secretariat, with the consent of Bishop Victoria, decided to move the weekends back to the spring. No weekends were held in 2007 and in 2008 we welcomed 7 men and 21 women.

Over the years we have seen a decline in candidates especially for the Men's Weekends and Secretariat are planning events in the coming year to hopefully encourage more participation. A Cursillo Information Event, Pulpit Talks and a Learner's Workshop have already been discussed and are in the planning stages.

Servant Community events included a presentation on Spiritual Direction given by Joe Forsyth and Rev. Terry Dunn. A teaching day for 71 attendees on "How Do Anglicans Interpret Scripture" was presented by Bishop Victoria and she also un-wrapped Paul's letter to the Colossians to 20 participants on another teaching day. Workshops on Sponsorship and Group Reunion were also held at monthly Ultreyas. We also had excellent attendance at an Ultreya when Greg Kerr-Wilson shared some excellent words of wisdom prior to him leaving for Qu'Appelle.

In June 2006 we hosted the Canadian Anglican Cursillo Secretariat Triennial Weekend at Kings College. It was a huge success with Cursillistas attending from across Canada. We were also delighted to have several people attend the weekend who have not yet attended a Cursillo.

Secretariat members have worked diligently this past year to update the membership list, and revise the duties and responsibilities of each position. Last year we also revised the Edmonton Cursillo Guidelines.

Team Training has been conducted the past 3 years with positive feedback from those participating.

On September 15, 2007 several Cursillistas had the privilege of assisting with a Habitat for Humanity build.

We have received and forwarded Palanca to Canadian and Worldwide Cursillo movements.

Secretariat has also had concerns this past 2 years of the decline in attendance at the monthly Ultreyas. We believe this is partly to do with Sponsorship of the Candidates. We would welcome some support and ideas on what we might do to encourage the Cursillistas to live out their 4<sup>th</sup> Day using the Cursillo method of Piety, Study and Action.

#### **ECUMENICAL OFFICERS**

Years ago I was told that in Edmonton there are a number of ecumenical "meta-parishes" that cut across denominational lines; for example, the Social Justice "meta-parish" includes Anglicans, Roman Catholics, United Church members, Presbyterians, Lutherans and others interested in justice issues – similarly, the Liturgy "meta-parish" draws a different but equally ecumenical crowd. And there is even an Ecumenical "meta-parish", made up of Christians from different traditions, who are interested in doing together those things which we are not obliged to do separately.

Your two Ecumenical Officers represent the diocese in gatherings of this ecumenical sort and communicate pertinent information and resources from the ecumenical community to the diocese as a whole, chiefly by means of the "Synod Scene." We'd be delighted to hear about ecumenical events at the parish level that we could promote as well. We both attended the North American Academy of Ecumenists convention in Saskatoon in September 2007, making contact with the Prairie Centre for Ecumenism in the process. The theme of the convention was "Reading Scripture Together."

The Rev. Eileen Conway has sat on the Edmonton and District Council of Churches for about three years and will serve as President of the Council 2008-2009. The EDCC coordinates four main ecumenical functions: celebration of the Week of Prayer for Christian Unity in January, the downtown Way of the Cross on Good Friday, the "Celebrating Our Faith" display at Edmonton City Hall (so far our commitment has been to provide an interesting display about Christianity for a few weeks beginning just before Easter), and the "No Room in the Inn" shelter-focussed

campaign at the Christmas Season. PLEASE NOTE that we are entitled, as a denomination, to at least FIVE more members than we currently have on Council!

Professor Jane Samson represented us at the World Day of Prayer in March 2008 at Trinity Evangelical Lutheran Church, and attends to the ecumenical dimensions of the educational chaplaincy at the University of Alberta, as well as working with the Chester Ronning Centre for the Study of Religion and Public Life, of whose Advisory Board she is a charter member. Professor Samson has been instrumental in inviting Msgr. Donald Bolen, of the Pontifical Council for the Promotion of Christian Unity, to speak at the King's College in early September on his work with the Anglican-RC and Methodist-RC dialogues.

The work of ARCIC was featured at an ecumenical Clergy Day hosted by the diocese at Holy Trinity (Strathcona) on December 8<sup>th</sup>, 2006. The featured speaker was the Rt. Rev. John Baycroft, retired Bishop of Ottawa and a long-serving member of ARCIC who led us through the recently published document on the understanding of Mary in Anglican and Roman Catholic thought and practice.

Professor Samson represents the diocese on the interfaith front, including attending meetings at the Interfaith Centre in Edmonton. She is also our representative on the City of Edmonton's Phoenix Multi-Faith Society for Harmony, and is presently co-ordinating Christian contributions to a project documenting interfaith collaboration in Edmonton's history.

It is commonly said that ecumenism on every scale is undergoing a kind of "winter." Certainly there are challenges in maintaining an ecumenical presence – organizational fatigue; turn-overs in personnel in many ministries; still, at the parish level, not much daily or weekly visible evidence of our full communion with the ELCIC. On the other hand, we rejoice locally in a positive ecumenical and interfaith environment, ongoing scholarly and theological conversations among the denominations and among the faiths; and nationally in the vigorous ecumenical and interfaith initatives by our new Primate.

# EDMONTON CITY CENTRE CHURCH CORPORATION (E4C)

2007 marked E4C's 38<sup>th</sup> year of responding to people in need. E4C is one of the largest charitable human services organizations in Canada. It is also one of its most diverse – providing services to pregnant and parenting women, to pre-school children, to elementary, junior high and high school students, and to adults of all ages.

Our work feeds the hungry and builds individual and community capacity. We shelter the homeless and offer a range of supportive and affordable housing services. We promote early childhood learning, adult literacy and numeracy. We work to end sexual exploitation. We build strong families.

Throughout 2007, E4C continued to grow and develop in response to community need:

- We opened Holmes Place (named in honour of our first Executive Director, Rev. Art Holmes) as an adjunct to Elizabeth House, serving as a community based residence for formerly homeless women.
- In collaboration with the Metis Nation of Alberta and Alberta Employment & Immigration, we began the Women Moving Forward program to provide a focused group of resources in supporting formerly homeless women establishing independence.
- In partnership with the Edmonton Housing Trust Fund, E4C developed the Case Management Team, providing individually planned and targeted services and support. Both of these new services are aimed to break a cycle of homelessness and dependency.
- Clareview Head Start expanded to build both a capacity for school success and stronger family relationships.
- E4C worked with Alberta Municipal Affairs and Alberta Seniors to better develop our emergency shelter services and staffing at the Women's Emergency Accommodation Centre and also at our second stage housing and supportive services at Elizabeth House.
- Working with the United Way, Partners for Kids, and the City Centre Education Project, our child nutrition programs lead by the School Lunch program began to expand to new sites and new ages, ensuring that the needs of hungry children were met.
- E4C's ArtStart program tripled its size providing kids with exposure and training in the arts and acquired the support of Senator Tommy Banks as its Honorary Patron.

E4C's continued evolution as an organization will focus on helping those in need to acquire the skills to move toward and achieve independence. This evolution involves the greater internal collaboration among our programs and services in developing and operating within new external partnerships and collaborations.

Edmonton's facing a critical time in relation to sky rocketing housing and fuel costs which will hit our service users extremely hard. Now more than ever families will be faced with the cruel decision of paying the rent and utility bills or buying food for their families. We want to be there to assist those most in need by being able to offer safe affordable housing alternatives and ensuring food and nutritional programs are available.

As an example of the work we do, in 2007, our Lunch Program served approximately 404,950 meals to students from kindergarten to grade 9, while our Snack Program served 1,129,492 nutritious snacks from kindergarten to grade 6. Alberta's Boom negatively impacts the low-income families we serve and the children in those families and the need is increasing.

WEAC provided services to 712 women with an average stay of 41 days and help 57 women safe, affordable housing within the community.

## **EDUCATION FOR MINISTRY**

The Education for Ministry Groups are once again recruiting mentors and encouraging members of all parishes in the Diocese to investigate EFM for a comprehensive study and reflection on living into our Baptismal Covenant as part of our faith journey.

In June, 2007, seven people celebrated their graduation from the EFM classes mentored by The Reverend Paul T. Robinson at St. Augustine of Canterbury Anglican Church. Dr. Patricia Bays attended the graduation as a guest speaker. Graduates enjoyed meeting participants from previous classes.

For the year 2008, The Reverend Robert Peel and Ms. June Miller mentored the EFM class which meets at St. Augustine's Anglican Church. This group has 10 students; one in the fourth year of study, two in the third year, and seven in the first year.

With the full support of Bishop Alexander, all parishes were invited to send interested people to an introductory EFM session at All Saints' Cathedral on Sunday June 8<sup>th</sup>, 2008. Organizers were pleased that 30 people came to the session to learn about EFM. As a result of this introductory session, a training session for new mentors was held June 26-28<sup>th</sup>, 2008. The EFM Program in the Diocese now has a number of new mentors and co-mentors. Two new EFM groups are planned for September 2008.

Graduates of EFM meet monthly at All Saints' Cathedral. One of the objectives of these meetings is to continue their ongoing educational component with a discussion of various books they have agreed to read. Another objective of the group is to plan activities in the Edmonton Diocese, with a view to providing information about the EFM programming available to all parishes in the City of Edmonton and surrounding area.

The Bishop appointed Percy and Anne Palmer as EFM Coordinators for the Diocese of Edmonton. With these appointments, EFM Edmonton now has contacts with EFM Canada. They will be planning and assisting with our Diocesan EFM activities on a regular basis.

The EFM coordinators would like to meet with the Bishop and members of the Executive Committee in the coming months to encourage the Diocese to become a sponsored Diocese with EFM Canada.

## **EXAMINING CHAPLAINS**

The Examining Chaplains are a group of 12 people, appointed by the Bishop to assist in the discernment process of those who feel called to ordained ministry.

When someone inquires about the possibility of ordained ministry, they enter into a lengthy period of prayerful discernment with the Bishop, their rector, the parish, the examining chaplains and ACPO (The Advisory Committee for Postulants for Ordination). In the course of this they receive appropriate education, ministry experience and spiritual direction.

The Examining Chaplains assist the Bishop in overseeing this process. They set up guidelines for parish discernment, they conduct interviews, they monitor the growth in each candidate, they provide support and encouragement and they are an advisory group for the Bishop in decisions around ordination. The Examining Chaplains have an active role from the first inquiry to ordination to the priesthood and placement in a parish. They also provide pastoral assistance to those who discover, as they make their way through the process, that they are called to an active lay ministry rather than ordained ministry.

Since the last regular Synod 42 individuals have been at some stage of the discernment process. In the past three years sixteen people have been ordained transitional deacon and/or priest. Two have been ordained to the vocational diaconate. There are currently ten people who are actively in various stages of discernment. There are also a number of people who, for various reasons, are "on hold" or in a very long term process.

In the past three years the Examining Chaplains have worked on establishing a consistent parish discernment process, on refining interview questions and on developing a vision and guidelines for the vocational diaconate.

It has been a delight to work with Bishop Victoria Matthews and with Bishop Jane Alexander. I am indebted to the previous chairs of this committee: The Rev. Peter Yeung and Mr. Joe Forsythe. Members of the Examining Chaplains are conscientious, hard-working, prayerful, insightful and compassionate. I thank them all for being part of this ministry.

# HISTORY COMMITTEE; DIOCESAN ARCHIVIST

Including the report of the Diocesan Archivist

This committee has not met as a group for over a year now. Instead the group serves as resource personnel for the Diocesan Archivist, Kathryn Ivany. Our last corporate action was to send to each parish a list of materials held in the Archives, and we encouraged the parish representatives to "fill in the blanks" and to continue to preserve their history.

As a member of the History Committee, the Diocesan Archivist draws on the help of other members as she prepares for our Diocese's centennial celebrations in 2013. We are hoping there will be a book detailing the life in this Diocese. It will require Committee members to assist with research in the Anglican Archives held at the Provincial Archives building. In the meantime, 2 volunteers for the Archivist are assisting with the sorting and cataloguing of the donated

materials so it can be found as well as preserved in the Archives. A third volunteer has been assisting the Archivist with research projects to lay the foundation for the centennial. The Archivist is extremely grateful for their assistance and support.

In the first year of her appointment, the Diocesan Archivist has responded to requests for historical information about the Diocese, and our sister Diocese of Athabasca (the records of which are also held at the Provincial Archives) from researchers within and without the Diocese, including those of the National Church Archives and researchers from the federal government relating to the Residential Schools issues. There have been requests from individuals for their own personal records: baptismal, marriage and death certificates as well as from parishes and diocesan organizations for historical information and assistance in how to preserve and store their records with historical value and when to transfer them to the Archives. There were approximately 25 requests for assistance and two visits to parishes to pick up records. Five donations of materials were made through the Synod Office as well, including material from Bishop Matthews and the Electoral Synod.

The History Committee members hope that every parish will take the time to make sure that their valuable records, containing the history of each parish, is in the Archives where it can be found when needed. There were requests this year that were unable to be answered because the registers containing the baptismal records were not turned over to the Archives when the parish closed. The search for the missing registers continues.

We continue to receive praise for the ease of researching the materials of the Diocese of Edmonton in the Provincial Archives. Let's keep up the good work.

## INNER CITY PASTORAL MINISTRY

Since the inception of Inner City Pastoral Ministry thirty years ago, the ministry has sought to affirm with the church and live out within the inner city community its mission statement: "The Inner City Pastoral Ministry is an interdenominational Christian Ministry of presence. In partnership with community and guided by the Spirit of God, we walk with the people of the Inner City of Edmonton."

Birthed from the visionary leadership of the United Church, ICPM continues to be a ministry of presence. People of the inner city receive help and guidance in spiritual matters and counseling. Sunday by Sunday the Emmanuel Community gathers at the Bissell Centre Drop In for prayer, worship and a hearty lunch. A "stow away" altar was built that contains all the needed regalia, linens and symbols of worship to create this Sunday morning sacred space. A colorful and strikingly artistic banner, designed with both Christian and Aboriginal symbols of faith, quilted by the women of St Paul's Anglican Church, Leduc, helps immensely in transforming a plain room into a worship space.

The overwhelming generosity and passionate concern of the over 110 church and faith communities enable a weekly Sunday meal within the life of the ministry. Thank you to the many volunteers that make this ministry happen. Visiting and building relationships with the people of the inner city is our passion. Meeting people on the streets, sharing time with people within the many Drop In's, shelters and food kitchens, along with visits in homes, hospitals, the Remand Centers and the Edmonton Institution for Women fill our days. Referrals of individuals for needed food, clothing, shelter and addictions counseling links the ministry of ICPM to local support agencies.

Advocacy and education form the basis of our social justice ministry tackling "people issues" as broad as homelessness and housing, the vulnerability of women within the inner city environment, and the concerns of 1<sup>st</sup> Nations, Métis and Inuit people.

The Pastoral Team of ICPM is Pastor Rick Chapman, and part time Pastoral Associates Sister Marion Garneau (SCIC) and Linda Winski. Supported by the ecumenical board of ICPM, and as representatives of the wider church community, the Pastoral Team reaches out and ministers amongst the wide variety of people and conditions found within the inner city. The impoverished, fixed income seniors, persons with mental health disorders, addictions, misguided youth and people simply down on their luck are the many who receive from the Pastors a word of care, encouragement and prayer, the assurance of God's love and mercy.

ICPM would not exist without the continued financial support of its ecumenical partners, namely, the United, Anglican, Lutheran and Roman Catholic Church. Together, we continue to fulfill the mission mandate ... "ICPM is an interdenominational Christian ministry of presence. In partnership with community and guided by the Spirit of God, we walk with the people of the Inner City of Edmonton."

Lay hospital visitors typically commit to four hours per week and make monthly reports to the coordinator. Training sessions for those interested in exploring this form of ministry will begin again this fall. We have a wonderful, dedicated executive that organizes our fall weekend encounter as well as an annual spring community event. In addition, the executive oversees the ongoing groups or 'spirals', which get together regularly throughout the year. Spirals provide an opportunity for encountered couples to maintain the skills they've learned on the weekend. We currently have six active spirals in Edmonton and surrounding area.

The year 2007 marked twenty five years of existence. Since 1982, hundreds of married couples' lives have been impacted. We held our 25<sup>th</sup> anniversary celebration on Saturday, April 12, 2008 at the North Glenora Community Club. It was a wonderful evening of celebration and fellowship. Special acknowledgements were made to John and Nicky Waite from Abbottsford, B.C. who had been on the presenting team in 1982 and continued to be involved and supportive throughout the two and a half decades. Also recognized for their many years as clergy couple on the presenting team were Father David and Patti Prowse of Jasper, Alberta. Two couples were acknowledged for their leadership of the Edmonton organization:

- (1) Richard Pougnet & Lavonne Roloff who attended the very first weekend in Edmonton and have remained involved in the Marriage Encounter Community from that time.
- (2) Garry and Heather Tansem who are the current area coordinating couple as well as the weekend coordinators and have been involved since 1996.

## NATURAL CHURCH DEVELOPMENT

Natural Church Development (NCD) is one of the Diocesan initiatives under the guidance of the Stewardship and Financial Development Committee (SFDC). As noted in the SFDC Report, NCD was initiated in the Diocese in February 2007 as one of the *Letting Down the Net* initiatives.

This report gives a brief overview of Natural Church Development and the work underway in the Diocese.

What is Natural Church Development? Natural Church Development is a new way of thinking about church growth by focusing on the quality or health of the church and not just on the numbers or quantity. Natural Church Development is a long-term strategic process for progressively improving a church's health. Growing a church, like growing a plant, requires a long-term commitment, which is intentional and consistently addressing the most critical issues facing the church at each stage of growth. Growing churches consistently exhibit eight quality characteristics: empowering leadership, gift-oriented ministry, passionate spirituality, functional structures, inspiring worship service, holistic small groups, need-oriented evangelism, and loving relationships. Churches interested in NCD complete a survey to determine their "scores" in the eight areas. Those areas needing most attention are identified and plans put in place to address them. Surveys are repeated annually to assess progress being made.

**NCD** is well underway in the Diocese. In February 2007, an initial workshop was held for those interested in considering a NCD coaching role as well as a workshop targeting some parishes where it was felt NCD would be of interest. In June 2007, a Diocesan Gathering was held to introduce NCD to the Diocese. At that time Carol Blair was appointed to serve as NCD coordinator for the Diocese. In November 2007, a NCD workshop, conducted by Ian Campbell, Director of NCD Canada, was held for those parishes implementing NCD.

As of June 2008, the current status of NCD in the Diocese is:

- Ten parishes have implemented or are currently implementing NCD (in various stages of implementation), with another six parishes expressing interest.
- Up to five coaches are available to provide presentations to parishes and to offer ongoing coaching support if desired by the parishes.

**NCD resources are readily available.** For parishes interested in learning more about NCD, additional information can be found on the NCD Canada website (<a href="www.ncdcanada.com">www.ncdcanada.com</a>) as well as the Diocesan website. Contact with Carol Blair may also be made through the Diocesan Office.

My appreciation and sincere thanks are extended to the Bishop, Executive Officer, coaches and parishes for their interest, support and ongoing commitment to NCD in the Diocese. We look forward to continued interest and growth in NCD as one important tool and process to continually build healthy churches in the Diocese.

#### PLANNED GIVING OFFICER

I have made planned giving presentations to 26 parishes and at three Wardens and Treasurer's workshops. More workshops are booked for the fall and winter, some of which will be return visits to parishes to talk specifically about stewardship. Since October 2006 the planned giving presentations have been accompanied by an introductory homily about stewardship. The presentations have prompted a number of people to revise their wills to include the Church while others have changed the beneficiary on their life insurance policies.

I have prepared and distributed to parishes a pamphlet about planned giving in general, plus pamphlets on eight planned giving topics: Will Power (bequests), Life Insurance, Gifts of Publicly Traded Securities, Charitable Gift Annuities, Retirement Funds, Giving a Strip Bond, Charitable Remainder Trusts, and Gifts of Residual Interests. Additional copies will be printed as needed. I have also prepared a number of articles on a variety of planned giving topics that have been published in *The Messenger*.

Executive Council approved a "Planned Giving Policy and Guidelines" at its November 2005 meeting. A companion document, "Guidelines for Accepting Planned Gifts to Parishes", was issued to each parish in January 2006 and is available on the Diocesan website.

Since the tax rules changed in 2006 with respect to gifts of securities—they now result in no taxable capital gains—parishioners in several parishes have taken advantage of the change to use gifts of appreciated securities to fulfill their annual pledges. The Provincial tax credit for charitable donations was changed in 2007 and gifts greater than \$200 now receive a 50% credit. A tax credit calculator is available on the Diocesan website.

I have worked with the Development Office of General Synod to issue several Charitable Gift Annuities. In each case, the parishioners involved received a donation receipt for a portion of the gift and they will also receive tax free income for life. (Tax free income is age dependent.) The respective parishes will receive most of the donated principal upon the death of the donor. In at least two cases, the parishes are receiving extra donations equal to the income from the annuity as the donors did not need the added income, preferring the additional tax credit instead.

I work closely with the Stewardship and Financial Development Committee. In October 2006 the diocese was selected to be a "pilot" for *Letting Down the Nets*, an initiative of General Synod. The Committee and I worked with LDTN to bring a focus on stewardship to the diocese. Several stewardship events were held, and a "Christian Stewardship in the Diocese of Edmonton" pamphlet was prepared and distributed. More recently, the Committee has been focusing on Natural Church Development. So far, ten parishes are using NCD to assess their strengths and weaknesses to plan their futures.

## PRAYER BOOK SOCIETY OF CANADA

Why do we, the Prayer Book Society of Canada (PBSC), exist as a society? In short, to defend and propagate what we hold to be a model of liturgical excellence, the classical Anglican liturgy inherent in the *Book of Common Prayer* (BCP). While the PBSC has always been open to liturgical renewal and refinement we believe that the BCP should be the reference point from which any revisions take place. In espousing the BCP our members find two major objections to the liturgical reforms undertaken over twenty years ago manifest in the *Book of Alternative Services* (BAS):

- a. pastoral
- b. aesthetic.

First, the major concern, pastoral. The English reformers of the 16<sup>th</sup> century changed our concept of confession. Rather than being solely directed to the intermediary of a priest for the confession and absolution of our sins, we are now called to confess our sins directly to our God (while still having the option of recourse to a priest for sacramental confession). We are assured that God will, through the sacrifice of Christ on the Cross, forgive our sins – *if we ask him to*. To ensure that we do ask Him to forgive our specific sins they devised a form of liturgy that is so inherently penitential – more so than what it replaced – that we sinners can not possibly miss the point. In the BAS liturgies, largely borrowed from the English (ICEL) translation of the new Roman Catholic Latin Mass, we have radically purged the liturgy of this penitential call. If the proper aim of the Church is to save souls, by deliberately purging our Anglican liturgy of this persistent call for repentance we have diminished the chance of the Church in achieving that goal. We are firmly convinced that the BAS liturgies put our parishioners at spiritual risk. In taking due care of our spiritual welfare, we would maintain that the BCP is complete; the BAS on the other hand is incomplete and parishes that do use it exclusively need to hear on occasion that penitential message of BCP worship – if we really do care about the spiritual welfare of our flocks.

The other question, aesthetics, is less grave for us personally but surely of great consequence for the Church. Our sacrificial offering to God should be the very best we can offer in terms of language, music, vestments, banners, etc. Our modern reformers consciously chose ordinary language; the BCP offers language that is by contrast noble and beautiful, certainly the very best that any English liturgist could offer. And in some cases ICEL translations are even erroneous: "And also with you" is not a proper translation of "Et cum spiritu tuo"; the BCPs "And with thy spirit", reminding us that we are spiritual beings accidentally inhabiting a physical body, is correct. There are impending changes to the English translation of the current Roman Missal which will correct such translation problems and render the liturgy into a much more appropriate style of language. Since the BAS liturgy largely followed the Roman pattern of Eucharistic liturgy and leaned heavily on the ICEL translations, it would be reasonable for Anglicans to turn again to Rome and borrow from this new English translation of the Mass. The PBSC on the other hand would suggest that we would do just as well to turn to what we already have, the classical English liturgy of the Book of Common Prayer.

Since the last Synod, the Edmonton Branch of the Prayer Book Society of Canada has continued to offer talks, three or four a year on average, intended to propagate knowledge of our Anglican tradition and especially the BCP. We have also engaged in the crisis in the Canadian Church by organizing events like last year's round table discussion on the St. Michael Report chaired by

Bishop Victoria. In current year's series of activities we will organize talks and other events, which will normally follow worship, Matins or Evensong. We will ask our speakers, often parish priests, if they can host the events in their parish. We hope that they can offer to conduct BCP worship for us to precede the talks. Given that so many parishes have lost the habit of worship with the BCP we are prepared to assist by providing a nucleus of choristers. In fact we would encourage any parish attempting to introduce Prayer Book worship into their parish to look on the PBSC as a resource to lean on as need be.

## PRIMATES WORLD RELIEF AND DEVELOPMENT FUND (PWRDF)

PWRDF helps Canadian Anglicans pray, act, and give in order that suffering people around the world can experience God's healing love shared in Jesus' name.

People of the Diocese of Edmonton have been faithful supporters of PWRDF for many years.

Initiatives in the Diocese of Edmonton since the 59<sup>th</sup> Synod, October, 2005 have included:

- A wide variety of special events and projects organized by PWRDF Parish Representatives and Clergy in local parishes
- 2 Workshops each year for Parish Representatives
- A Diocesan 'Steering Committee' comprised of Marion Bulmer (Former Diocesan Coordinator), Geoff Strong, Mark Vigrass, and the Rev. Stephen Hallford

Financial contributions from people and parishes of the Diocese of Edmonton transferred through the Synod Office to PWRDF totaled:

\$82,139.83 in 2005

\$75,344.74 in 2006

\$73,070.71 in 2007

(Please note that many people and parishes made contributions directly to PWRDF during these years which are not reflected in the Synod Office figures.)

Approximately 74% of PWRDF's income is from voluntary donations and bequests from individuals and parishes. The remaining 26% comes from the Canadian International Development Agency (CIDA).

PWRDF works with Anglican Dioceses, ecumenical organizations, and community-based development groups in approximately 30 countries to address the causes of poverty and improve the quality of life for vulnerable people.

PWRDF works with 12 Indigenous Partners in Canada to empower First Nations youth and women, promote traditional knowledge and languages, and find common ways to meet the needs of Indigenous Peoples of Canada.

PWRDF helps Canadian Anglicans respond to emergencies around the world with on-going and special appeals for funds. These funds go to Action by Churches Together (ACT). ACT is a global, ecumenical alliance of churches responding to catastrophes around the world. PWRDF gives priority to emergency appeals from Africa, the Middle East, Asia, and Latin America.

From 2004 – 2007 PWRDF operated a special program called Partnership for Life (PFL). PFL was a fund and awareness raising initiative to help Canadian Anglicans alleviate the suffering around the world caused by the HIV / AIDS epidemic. Over the course of PFL PWRDF received over \$3 million which has been allocated to PFL.

Thank you to the Steering Committee Members, PWRDF Parish Representatives, Clergy, and People of the Diocese who have generously prayed, acted, and given so that PWRDF could reach out in Jesus' name to people around the world who need help.

## REFUGEE CORDINATOR

The three years since the last report to Synod have been very busy for the parishes that are participating in refugee sponsorship. Holy Trinity, St. George's, St. Timothy's, St. Thomas of Sherwood Park and St. John the Evangelist, are either helping new arrivals or waiting for new families to arrive. Special plans are in process by P.W.R.D.F. for all dioceses across Canada, for later this year.

Holy Trinity has embarked on their first sponsorship of a Joint Assistance Refugee family. This is a huge undertaking, as Joint Assistance families are usually very high needs. For this reason, the Government provides the means for food, clothing and shelter and the sponsoring group provides the hands on settlement help. Holy Trinity has a very strong team and with God's help will do a great job.

- St. Thomas in Sherwood Park has made application for several individuals, who are family of refugees they had previously sponsored. Thank you to Marion Bulmer for her great leadership skill and passion for refugee sponsorship.
- St. George's Parish has had one family arrive within the last three years but they are still anxiously waiting for news of an interview date for a family from Kenya. Please keep the parish and this family in your prayers, as they have been waiting almost four years.
- St. Timothy's Parish has given its approval for the sponsorship of a single female, Joint Assistance Sponsorship. To date there has been no one to match the parish to. I am confident we will be able to find someone for them soon.

St. John the Evangelist Parish has sponsored two Joint Assistance families in the past three years and are looking ahead to make an application in the near future. They also have a sponsorship in the works out of Kenya and are patiently waiting word.

With the help of Marion Bulmer and Scott McDonald we put together a power point presentation about sponsorship and would be delighted to use it to promote sponsorship in the diocese. Feel free to call the diocesan office for my contact if you would like to have me present it.

The exciting news from P.W.R.D.F. is that, in celebration of their 50<sup>th</sup> Anniversary, the Primate's World Relief and Development Fund, is asking Anglican Dioceses across Canada to sponsor a total of 50 families. Arrivals will hopefully happen between Oct. 2008 and Oct. 2009. The families to be sponsored will most likely be Visas Office Referred. This means that they will already have the clearance of the Visas Office overseas and therefore will come in a more timely fashion. It does however mean that the parish is responsible for both the financial and the settlement of these folks.

A thank you to St. George's, St. Thomas, St. Timothy's and St. John the Evangelist parishes for their participation in this very important outreach. This way we can help one family at a time.

Please pray for those Parishes that are sponsoring and also that more parishes would see sponsorship as their calling and would receive the blessing of seeing these families alive and healthy.

# TOGETHER ENCOUNTERING CHRIST (TEC)

2008 has been a challenging year for TEC. This is a bit surprising because most participants agreed the TEC May long weekend in 2007 was one of the most Spirit-empowered events we've had in recent memory. Despite this, few of the new candidates subsequently attended the Annual General Meeting two weeks later, and even fewer volunteered for positions on the Steering Committee to help guide TEC through the next year (2008). Louis Rowe, the youth director, never did find an assistant youth director who could shadow him in 2008 and take over as youth director after he was scheduled to step down in June 2008. Despite these challenges, we had a wonderful Fourth Day Event in November 2007, where we helped Rev. Wendy Ainsworth serve dinner at St. Faith's Church. Louis also organized a powerful TEC mini-weekend in February 2008 at St. George's church led by Rev. Don Aellen. Despite these highlights, the Leadership team got a late start in selecting a Core team to lead the weekend for May 2008 and concerns grew about timelines and recruiting all the necessary people, so prayerfully we decided to do something different. Our Core adults, Robyn Thompson and Grant Kemp, organized a special visioning retreat called One in a Crowd: God in the Midst of Us that was held from Saturday night to Monday afternoon on the May long weekend at Camp Van Es. It was attended by about 30 people, mainly young adults and by all accounts was a wonderful time of renewal and spiritual growth. Still, only 15 devoted souls attended the TEC Annual General Meeting at Laurier Park on June 12, 2008.

TEC is clearly going through a transition. There are several factors that have contributed to the apparent apathy described above. First and foremost, we have had problems with

communications all year, and as adult advisor, I take full responsibility for this. I commend Gina Blank for her great work on the TEC website, and Margaret MacLaren for all her hard work telephoning and emailing, but Leadership needs to adhere better to timing and timelines. Secondly, it's hard to measure the impact of Bishop Victoria leaving, the interim during selection of a new bishop and the influence of the general uncertainties of the Anglican Church of Canada and the impact of the meeting of the General Synod. In addition, Rev. Kevin Kraglund, who took over from Rev. Stephanie London-Crane in 2007 as TEC Spiritual Director, will focus on his parish and new son in the coming year. Thus TEC awaits the appointment of a new Spiritual Director.

The future of TEC seeks guidance from the Holy Spirit. To allow us to be led by the Spirit, it was decided at the AGM this year that the Steering Committee will meet for a meal and bible study together at the home of the adult advisor, while focusing our attention on planning and recruiting for the 2009 TEC May long weekend. Our goal is that TEC weekend 2009 will provide an infusion of enthusiastic, committed young followers of Christ to participate in the TEC of 2009-2010. I am encouraged by the support that Bishop Alexander has expressed to TEC and I envision a stronger coordination between all aspects of youth and young adult ministries across the Diocese wherein together we can encounter Christ.

# Friday, October 21<sup>ST</sup>, 2005 All Saints' Cathedral, Edmonton

The 59<sup>th</sup> Synod of the Diocese of Edmonton opened with a Eucharist service, which included the Bishop's Charge. Following the service, the meeting was called to order.

# Chair - Right Reverend Victoria Matthews, Bishop

## 1. Call to Order

The meeting was called to order at 8:52 p.m.

# 2. Appointment of Secretary of Synod

The Chair appointed Barbara Burrows to be Secretary of Synod.

# 3. Election of Clerical and Lay Recorders

Barbara Burrows announced that the **Reverend Matthew Oliver** has been nominated as Clerical Recorder and **Nona Wilson** has been nominated as Lay Recorder for the 60<sup>th</sup> Synod.

Moved by **Barbara Burrows**, and seconded by **Chelsy Stevens** that nominations be closed. **CARRIED**.

The Chair declared that the **Reverend Matthew Oliver** is acclaimed as Clerical Recorder and **Nona Wilson** is acclaimed as Lay Recorder for the 60<sup>th</sup> Synod.

**Note**: The Reverend David Prowse and David Holehouse are the recorders for this Synod as elected at the 58<sup>th</sup> Synod.

# 4. Report of the Credentials Committee

The Chair announced that the co-chairs of the Committee for Credentials and Registration are The **Reverend Joanne Chambers**, member of the Order of Clergy and **Mrs. Liz Hubbard**, member of the Order of Laity.

# 5. Presentation of the Lists of The Members Of Synod to the Clerical and Lay Recorders The Credentials Committee presented the lists of the members of Synod who are entitled to be present and vote to the Recorders.

## 6. The Clerical Roll

The **Clerical Recorder** certified that he had received the roll of the clerical members of Synod, and had determined who and how many were present and entitled to vote. There are 97 members of the clergy who are delegates to this Synod and 64 are registered and entitled

to vote.

# 7. The Lay Roll

The **Lay Recorder** certified that he had received the roll of the lay members of Synod, and had determined who and how many were present and entitled to vote. There are 190 lay members who are delegates to this Synod and 145 are registered and entitled to vote.

# 8. Motion to Accept The Rolls

Moved by **Rev. Joanne Chambers**, and seconded by **Liz Hubbard** that we accept the rolls. **CARRIED**.

# 9. **Quorum**

Rev. **JOANNE CHAMBERS**, Chair of Credentials Committee reported that, there being present at least one third of the members of the House of Clergy and at least one third of the members of the House of Laity, there is a quorum for this Synod.

# 24. Report of Credentials Committee

Rev. Joanne Chambers and Liz Hubbard announced the number of members registered: 67 members of clergy registered; 164 members of lay registered. Total of 231 present.

# 25. Balloting Procedures for Elective Positions Explained

**Rev. Anne Wightman** led delegates through the election procedures. Ballots to be completed and in by 12:30. Instructions – Removal of Will Drake in Battle River; removal of Shawn Milley, replace with Robyn Thompson in Whitemud; add Scott Walker on laity side for Diocesan Court, (non member of the Law Society). Add Hy Dahl to Yellowhead, for Church Development Trust Fund.

## 26. Presentation: PrayerWorks Hall

**David Connell, Rev. Maureen Crerar,** and **Rev. Wendy Ainsworth** presented a report on PrayerWorks Hall at St. Faith's. Wendy and Maureen reviewed the progress of the parish of St. Faith's providing meals to people in need, and to serving them with dignity and respect. Their project became a diocesan project, providing meals, an after-school program, meetings, community space. David described the diocese's involvement and the naming of PrayerWorks Hall – prayer does work.

Notes from the presenters are included in the Appendix.

## 27. Legislative Committee Report

**Chancellor David Jones** presented the report of the Legislative Committee as printed in the Circular – (Appendix 5).

There were five legislative issues, concerning the time parish annual meetings are held, period of notice required for special meetings of Synod, a new Canon 10A governing management of the Church Development Trust, some corrections and alterations to the Constitution and Canons, the different meanings of geographic or historical "missions" (a note to be included at the end of the Canons for information, not a Canon in itself), and relationships between parish corporations and vestries (another note designed to be helpful when questions arise). David answered questions of clarification. Notes from this discussion are included in the Appendix.

## 28. Members' Concerns Time

This is time in which members addressed concerns they might have around the life of the Diocese. Such issues raised are not meant for debate, and there should not be rebuttals.

**Rev. Elizabeth Thompson**, St. Augustine's, Parkland – I would like to thank those people on the Dream Team (at Diocesan Office) that had to compile all the reports. There are several omissions however on Page 75 regarding changes in clergy status. Bishop replied Barb White will correct.

**Rev. Stephen Hallford**, Diocesan PWRDF Coordinator – expressed thanks to each parish and their parish reps for bringing PWRDF to their people. There is a tremendous amount of suffering after the earthquake in Pakistan/Kashmir, the good news is that the federal government will match any contributions we make until October 26. Thus every dollar we give will cost us 60 c after tax credits, and will result in \$2 relief on the ground.

**Brian Burrows**, All Saints' Cathedral – regarding the announcement yesterday of the Supreme Court decision on federal liability in residential schools cases – some people in the parishes said to me it sounds as if this was a bad thing for the church. I think it would be helpful if someone explained to us the significance of that decision.

**David Jones** replied – The decision comes out of a residential school that the Presbyterian Church founded and the United Church took over in Port Alberni, B.C. There was sexual abuse at the school, there was litigation and the trial court found the federal government 75% vicariously liable because they ran the school, and the United Church 25% liable. The Court of Appeal of B.C. then found that 10% of vicarious liability lay with the federal government and none with the church, suggesting the charity should be immune from vicarious liability. The Supreme Court of Canada has now ruled there is no immunity from liability, and has reinstated the liability formula. In doing that, the Court also said there were some other claims about damages that had happened earlier than the "limitation period," and one question was – could you look at those earlier facts to increase your damages? The Court said No. The period of limitation prevents that. However the limitation for sexual abuse doesn't start to run for a long period of time. Also, though the Court said we won't talk about cultural deprivation claims, they gave some very clear indications that the mere going to a school is not by itself a legal wrong. For us as church, I think it means we settled with the federal government, the federal government has then been sued by people who attended Anglican schools where wrong was done, and the federal government then relentlessly third-partied the Anglican church, saying it was 50-50 liability. The Supreme Court now says it doesn't have to be 50-50, each case must be settled on its facts. The Anglican Church in fact settled at 70-30, with us accepting 30% of the liability. We also have a cap of \$25 million on our liability. By settling, we got rid of all the litigation costs which undoubtedly would have bankrupted the church and some dioceses. So at the end of the day I'm quite content that we settled. Our settlement doesn't cover cultural deprivation – that's still being dealt with, as to whether that's a legal wrong. I'm not sure if the Supreme Court will recognize that. And the federal government in talks with the Assembly of First Nations has set up a task force under a recently retired judge to make recommendations to the federal government about some global method of settling the cultural deprivation claims. The AFN has suggested something like a lump sum to everybody who went to the schools, plus an additional sum according to the number of years you spent there. The retired judge will report back next March-April. The federal government wants to find a global way to deal with that issue, rather than go case by case.

**Rob MacMillan**, St. Andrew's, Camrose – I'm glad to hear the PWRDF is supporting the Pakistan campaign, but another country under the radar is Guatemala – they have suffered great tragedy as well. Are they looking at a campaign for Guatemala? Could they lobby the federal government for the same (dollar matching) deal?

**History Quiz** – **Beth-Anne Exham**, Chair of the History Committee for Diocese, provided answers to a History Quiz at various points during the proceedings. The questions, and her answers, are included in the Appendix.

# 29. St. Michael Report

**Bishop Victoria Matthews** – report on blessing of same sex unions. The Bishop is Chair of the Primate's Theological Commission, to which the matter of how the issue relates to concepts of doctrine was referred in June, 2004. General Synod asked the Primate to refer it to the commission to decide if this matter was doctrinal or not. It is an important question because the way we make decisions differs as to the weight of the question. If we suggest it's doctrinal it suggests it needs to be a decision made by General Synod, not diocese by diocese.

Our report is now being referred to every diocese to be discussed. We will have a Diocesan Gathering on the subject.

The Bishop briefly took delegates through some key paragraphs of the Commission's report. On page 6, it is stated that the Commission has concluded that this is a matter of doctrine. On pages 9 and 10 the report says culture is a context in which Christians live out their faith and formulate doctrine. We have to see our norms through the eyes of Christ, and promote those norms that honor him.

On page 11 – what is doctrine? It is formed when the church makes a statement of who God is and how God acts, and as the blessing of marriages makes a statement about God, it must be considered as a doctrinal matter. The term doctrine is used several ways – teaching founded on scripture, interpreted in the context of tradition and in the context of reason. There are Core Doctrines, such as the earliest explications of Scripture regarding the Trinity and Jesus. There are other doctrinal issues where difference can be tolerated without disunity. The latter are still doctrine.

On Page 13 – The Church aspires to enter the fullness of truth. The Church has reversed positions before – such as on slavery.

The core of this is the development of doctrine. Some churches believe doctrine can never change, but this is not our position.

On the Cultural Context page, in paragraphs 39-41, the Commission articulates the importance of blessing.

The Bishop emphasized that while the 12 members of the Commission represent the whole range of opinion and background, there was full agreement that this is a matter of doctrine.

30. Presentation: Church Giving and Gift Planning – John Robertson

David Connell introduced the guest speaker, Archdeacon John Robertson, National Gift

Planning Officer with the Anglican Church of Canada, living in Kingston, ON.

Archdeacon John Robertson provided a number of insights into the scriptural and

procedural issues around church giving and gift planning. The call to stewardship and mission are part of one pilgrimage – what is God calling us to do right here, right now, and what is God calling us to become as a community of faith.

The Archdeacon was given a standing ovation for his talk and the gifts presented to the Bishop. Notes from the speaker's presentation are included in the Appendix.

Thanks to the speaker were extended by Carol Blair.

## 31. Resolutions

**Brian Burrows** announced that there was one resolution printed in the Convening Circular on page 59. He called on Rev. Chris Pappas and Art Jones, mover and seconder of the motion to speak to it.

## **Resolution 59-RC-1 Travel Assistance Program**

Moved by Chris Pappas, seconded by Art Jones:

Resolved that this Synod approves the implementation of a travel assistance program which will factor travel expenses into the formula for calculating apportionment and assessment.

**Rev. Chris Pappas**, Yellowhead Deanery - This resolution came from a deanery meeting last year, and just asks that travel expenses be factored into apportionment and assessment formula. We are allowed some deductions in apportionment if a parish has a mortgage, for instance, or if you have more than one clergy, if you have church staff, etc. We are asking that one of those factors be the cost of parish travel. This is really important for the rural parishes in other deaneries too. At St. Mary Abbot's, in September we paid 10% of the expenses in travel costs for that month. Travel costs me \$1,000 split between two parishes with annual budgets of \$50,000. It is a legitimate cost of what it takes to do ministry in our parishes.

**Art Jones**, St John's, Onoway – seconded – one goal of this diocese is to reach more self sufficient parishes, and anything we can do to save some of the money they now spend would enhance that possibility.

Discussion – Rev. Wendy Ainsworth, St Faith's, Edmonton – I support the motion. What percentage factor would be used? All parishes pay travel costs – I paid \$250 last month and my parish can't cover these costs either.

Rev. Chris Pappas – we didn't have a percentage in mind, we would allow the Synod Office to work that out.

## 32. Presentation: Youth Ministry and Summer Camps

**Rev. Stephanie London-Crane** introduced this report by indicating that God has blessed us with a number of wonderful youth programs, a number of people giving their time and energy and prayer in building up the next generation of disciples.

**Chelsy Stevens** provided a summer camp presentation with slides regarding Camp Van Es; wilderness camps and canoe camps. She expressed thanks to the sponsors whose donations allow many youngsters to attend.

**Grant Kemp**, youth director of TEC in 2005, described Together Encountering Christ as a stepping stone to life in Christ, similar to the Cursillo experience, but for the 16-22 age group. It is a chance to interact with youth in other churches in diocese, and with other denominations. Grant encouraged all parishes to encourage young people to go to TEC's mini weekend November 4 & 5.

**Rev. Kevin Kraglund,** from Gibbons-Bon Accord, spoke about a parish visioning process two years ago, in which one of the goals was an emphasis on youth ministry. We began a joint youth group with Bon Accord and Gibbons, ran Alpha for Youth last year for a dozen young people, this year we are running another teen program. Now we have decided to run the junior and senior youth ministry one evening a month. It is working quite well, though we would like to meet more often. I lead the senior group with a lay person, the junior group is led by the Rector's warden and Treasurer. We view youth ministry as a shared ministry.

**Amy Croy**, youth pastor at St. Paul's, Edmonton, reported that three years ago, the youth ministry adopted a three year cycle of missions, inspired by Jesus' instructions to be his witnesses to the end of the earth. In Year 1 we did local mission, in year 2 native mission, year 3 one to Guatemala.

**Evelyn Polet**, also from St. Paul's, spoke of her trip to Guatemala. They went to a village and two small towns in the northern region, inhabited by a Mayan tribe. They showed Christ's love to the people through action, built outhouses for six communities and put on children's programs. They worked in two orphanages, and did some home visits, attended a women's bible study, encouraged a youth group to reach out to their own rural community. It was an incredible experience, and the people gave them much more – Christ's universal love also. They would like to make this form of mission a tradition in our church.

**Sarah Taylor** of the Diocesan Youth Ministry-Youth Ministry Audit, reported that she was one of four who helped with the Youth Ministry audit for the diocese. Surveys were done with parishes in September and October. Preliminary findings: Youth Ministry varies widely throughout the diocese, with varying parish needs. The group recommends four regularly scheduled youth events to occur throughout the diocese, one of them rotating through rural parishes. This will encourage the building of community among youth in the diocese. Camps begin these relationships, and there is a need to follow through with that. They also want to

provide relief for youth workers from planning etc, to free them up so they can focus on relationship formation. They want to provide youth in parishes without groups the opportunity to attend events, and they want to develop opportunities for youth ministers to network amongst themselves.

**Stephanie London-Crane** mentioned three upcoming youth events: The TEC mini weekend at St George's in November; a young adult retreat at Strathcona Wilderness Centre in December, and a Star Wars movie marathon in December at the Cathedral, including a gathering for the leaders. All parishes are encouraged to develop youth offerings, and to encourage young people to attend diocesan programs.

# 33. Presentation: Strategic Plan Update

**Carol Blair**, Chair of Stewardship and Financial Development, presented this report, a copy of which is attached to these proceedings. In conclusion she expressed a thank-you to all who have helped move this plan forward.

## 34. Presentation: College Of Emmanuel & St. Chad

**Sarah Andrusco**, the Director of Development at the College of Emmanuel & St. Chad, attended in place of Dr. Walter Deller, Principal.

Ms Andrusco presented a DVD showing the history and programs of the college, based at the University of Saskatchewan. She offered an invitation to the diocese to continue its financial support to the college, which is celebrating its 125<sup>th</sup> anniversary. She said the college has an \$8 million capital fundraising program, to establish new program chairs at the institution. The college has raised \$1 million of this and continues looking for donors. The college faced the possibility of closure in April, but two donors redirecting their gifts have given it three more years to continue its campaign across the Ecclesiastical Province of Rupert's Land. The college hopes parishes will continue to earmark 1-2% of their funds for theological education, with perhaps some directed towards the college in Saskatoon. "Without theological education, we break the cycle," she said.

The Bishop named a number of previous graduates who now serve the Diocese of Edmonton, and said some from the diocese have given seminars there, "so we certainly have a good relationship."

# 35. New Clergy Introductions

The **Bishop** introduced some new members of the clergy; one coming back home to the diocese, Bryson Randall; Karen Hunt from the diocese of Nova Scotia and PEI; Shawn Devlin from the Diocese of Toronto Trinity College, now assistant curate at Holy Trinity Edmonton; Mary Gavin at Christ Church, as associate for an interim period, from the Diocese of Saskatoon.

# 36. Presentation: Video On Aids / Africa

**Robyn Thompson** presented a video on behalf of General Synod delegates. She commented on her experience as a member of General Synod. Her first impression was that representatives from our diocese were a wonderful group to be with. Despite our differing opinions we had fun and worshipped together. The second impression was the overwhelming impact of Stephen Lewis's presentation. In 1984 he was appointed Canadian ambassador to UN, until 1988. He drafted the UN's African Recovery, and now is the Secretary General's

special envoy on AIDS in Africa, with a mandate to ensure the work done in 2001 on AIDS at the UN sessions was not lost. The General Synod delegates don't want this work to be lost, it is extremely significant, and so they want to share the presentation with you. HIV AIDS Africa is something PWRDF is working on, our representatives are committed to keeping it going, as well as water partnerships. If you are moved to act, please seek out your PWRDF representative or priest.

The video recorded a speech in which Mr. Lewis addressed the difficulty of getting African churches on board in dealing with the epidemic. He spoke of his frustration with the lack of recognition of the problem, the lack of drugs, the disproportionate decimation of the female population, the destruction of the community's productive capacity, and the huge numbers of AIDS orphans. "There has to be a mobilization of will in Canada and elsewhere to turn this pandemic around," he said. "We can show religious leadership in this country, among our own people with AIDS, by treating them with decency and compassion. Broaden that to the world, and your influence can be infinite."

The Bishop expressed thanks to Robyn and her leadership on the Eco Justice Committee.

# 37. Presentation: Administration And Finance Report

**Scott Montgomery** presented a report on organization and responsibilities of the A&F Committee. A copy of his slide presentation is attached to this report.

**Dale Purkis**, Executive Officer, presented a narrative budget for 2006. A copy is attached to this report. Dale said that a narrative budget is a tool for communicating with your parish on what your operation is all about. The 2006 Diocesan budget will be available after it is approved by Executive Council.

#### 39. St. Michael Report – Continued.

The **Bishop** reintroduced the topic, and invited delegates to make their comments at the microphone with questions or contributions.

**Renee Jackson**, St. Paul's: I really appreciate the work that this Commission has done in terms of referencing and citing scripture throughout the report. I find that very comforting. I would genuinely like to have scripture cited on paragraph 12, pg 13. It would make it easier for me to begin to understand and try to come to some kind of place of being open to a possibility, that when it says blessing is consistent with the teaching of scripture . . . could scripture be attached to that?

The **Bishop** – I won't do that right now, but will get back to you through the Anglican Messenger and Anglican Journal.

**Bryson Randall**, Holy Trinity, Tofield – I'm very heartened by paragraph 3, when the Commission called the whole church to engage in discussing this matter in a certain manner. Question – do you feel there's any chance that the dialogue is going to change?

The **Bishop** – I think there is a possibility that we could move into more constructive conversation (not that in the past it has been destructive totally) but I am aware of the tendency of people to speak to those who are like minded. On Clergy Day I asked people to sit with those they would not normally talk to – it didn't happen. At an Essentials event at the University of Alberta, I found exactly who I expected to see there. When Christ Church offered a dialogue series, I saw not entirely, but almost, exactly who I expected to see there. We shouldn't be afraid of each other, if we listen to each other we will learn. No one knows where this is going to lead the Anglican Church of Canada. At this point it is a very important conversation. I do encourage you in your parishes and in the diocese to continue the conversation. Faith Worship & Ministry have provided questions so that this can be engaged in a helpful way.

The Bishop invited delegates to take 5 minutes at their tables to discuss what does the word Doctrine mean to them, what do they think of when they hear the word?

#### 26. Presentation on PrayerWorks Hall

Rev. Wendy Ainsworth, Rev. Maureen Crerar, David Connell

**Wendy** –In 1999 I was part of the lay ministry team at St Faith's, people came to the door asking for food. There was no meal ministry at that time, but we were confronted with the need. A children's program was started at that time, one day a week when school let out early, they were coming to us without having had lunch, there was a concern for them too. We had a spaghetti dinner for about 35 people in June, 1999. The intention then was to respect the dignity of all coming needing food – we used real china and cutlery. We nourished body and soul and made everyone welcome. The outcome was that some people started coming into the church and not just the hall, we were able to begin to build the congregation. It created an interface for St Faith's with the community, it began the process of creating a safe place where people could be accepted.

Maureen – Past Rector at St Faith's. The mission statement for the parish is to reach out and grow in Christ's love. The basis for this ministry is the needs of the community. There were people on fixed incomes, various supports, assistance – many would say that after they had paid their rent they had only \$25 for a month's food. Also a lot of working poor, and many would say this is one good meal I can feed my family. Others had mental and other illnesses where shopping and cooking were not a part of their everyday life. Some had no cooking facilities at all. There was also homelessness where the basic need was for water and food. Our mission was to reach out to those in need with a meal and to serve people with dignity and respect. The theological framework is Matthew 25. Action was needed. Our response was to reach out in Christ's love. The problem was the parish was small; there were few people and resources. Secondly the condition of the parish hall was beyond repair. The kitchen was inadequate, but the mission moved forward. We asked people in other congregations to help us, we reached out to the family of our diocese. Teams came in to help set up and prepare and serve. Eleven parishes became involved with pulpit exchange, student helpers, etc. This expanded the ministry and changed the lives of people. We went from once a month meals to a soup kitchen every Thursday a Saturday breakfast each week. Rotary, Cursillo, TEC became involved, and we also built a women's fellowship guild. Outcomes have been many volunteers, and several hundred people a week going through the hall. Some have gone from eating meals to being on Vestry, some have been baptized. The hall was still a problem, however, and it was time to call upon the diocese – and this became a diocesan project.

**David** –We provide 10,000 meals a year, and have a Thursday after-school progam, AA meetings, womens and youth meetings, several community groups using the hall. We named it Prayer Works Hall in July, 2005, because prayer does work. On July 18, 2005, we had the sod turning, and construction began at that time. The budget is \$977,221, and completion is expected in early December. The diocese sold Elizabeth House, plus there is a CFEP grant, St Faith's fundraising, and an anonymous donor, bringing funds available to \$827,221. This leaves \$150,000, or 15% to be raised. Please consider a gift, or think of others who might help us out. What about the government's Prosperity Bonus of \$400 – youth idea is to give \$100 of it to this project.

**Wendy** – we now serve 150 people on the third Friday of each month, we have Thursday lunches for 70 people and more in the winter. We do Saturday breakfasts for 70-100. We will start to serve hot afternoon meal on Wednesdays. Some options for the future continue to be more meal programs, a drop in place that's safe, women's and children's program in the morning so women can get out. Our ecumenical contacts would like to come and learn how to serve the needs of the community and do something similar in their own community – St Faith's could become a centre of teaching.

### 27. Legislative Committee Report

#### **Questions of clarification:**

**Rev. Susan Storey**, St Thomas – Part 104 of proposed Canon 10A . If parishes are unable to give their 1% to the diocese for this purpose, does that leave the diocese in a difficult financial position? David replied – we felt it was something we could live with, wouldn't cause significant difficulty. Most parishes accept what they have been asked to; we were comfortable with this requirement.

Alan Roe, Emmanuel Gibbons, - this will change the parish apportionment, where will funds come from? David replied – Executive Council will have to determine this. Not all parishes are paying 1% into the Church Development Trust, so it may be a wash. It would only increase apportionment if this is an additional amount – but this is a way of making the Diocese budget that amount. It's a Diocesan obligation rather than saying every parish must pay 1%. We received \$24,000 from parishes, while we have to set aside \$48,000 – and we are OK with that.

**Alan Roe** – Regarding missions. We are the Battenburg Mission guys. Regarding Section 8 – I'm not sure how close points need to be to be operated as a single parish. We include three points. David – The Canons say you are one parish with one corporation, one vestry. This note (in the Legislative Committee Report) doesn't propose any change.

**Rob Hubbard**, Tofield: To clarify – are we going to now not have the 1% payment to the diocese as a parish responsibility? David replied – Yes, we will <u>not</u> have that, parishes will not make that 1% apportionment payment.

**Rev. Peter Yeung**, Vermilion – regarding parish structure. The corporation used to be the legal entity of the parish – (David – still is) – is it answerable to vestry and if vestry has an elected chair, does that person become the legal signing officer? If the parish wants to sell the rectory, it used to be the corporation would do all the legal work. David replied - it still would – the chair of vestry is the incumbent, who is also a member of corporation. But vestry may agree to create signing officers for bank accounts etc. This note note (in the Legislative Committee Report) clarifies the present structure, it does not propose any change

#### 30. Presentation: Church Giving and Gift Planning – John Robertson

It is absolutely essential in my view for parish clergy, lay leaders and diocesan leaders to have a compelling clear sense of vision, mission and outreach, a well articulated sense of program, of where you are going and why. The call to stewardship and mission are part of one pilgrimage. If you could just wrestle with two questions, you are doing well – what is God calling us to do right here, right now, and what is God calling us to become as a community of faith.

There are 80,000 plus charities in Canada, and I dare say that most of those have a clear sense of who and whose they are and where they are going. They have a well communicated sense of mission and purpose, with realistic goals. When coupled with outstanding ministry, program and outreach, and ecumenical work where possible, it's amazing what can be done.

Those with a good understanding of the theology of abundance rather than of scarcity are the faith communities that are moving forward; those willing to go out in faith and service to make an investment to make a difference in people's lives. Examples are Prayer Works Hall, and other projects that bring people in from the wider community and show them the love, compassion, and welcome that so many are yearning for.

When we can talk about the generosity of God and express it back to people, we are very much on the right track. Sharing is all about gratitude, about offering an act of thanksgiving to say how much we appreciate God's gifts. It is all about gratitude for God's gifts and blessings. Parishes and dioceses which make stewardship education a year-round priority, with a clear sense of vision and purpose, are the faith communities that are doing well, where people respond generously in order to make a difference. They treat volunteers well, with position descriptions, with recognition and thank-you's, encouraging people to share their time, abilities and talents, recognizing liturgically the gifts of people week by week.

In a parish of mine we had a Police Week, with gatherings and talks, and then a Sunday appreciation for these men and women. We did the same for teachers, medical people, etc, week by week, so gradually parishioners could see that what they were doing in the week was important and valued.

We need to learn how to be generous. It's good for us spiritually, we need to take it seriously and to be realistic. I used to think I was being quite generous with my support of my parishes, but when I did the math, I was shocked. The results were appalling -2% of my annual income was given for the work of God. I decided that didn't really reflect my sense of values and priorities, so I resolved to raise this gradually to at least the 10% standard. I thought that

God owns and gives everything, 100% of what I enjoy, so now I'm enjoying 90% for my own purposes and sharing the other 10% to say thank you God.

Some strategies for parishes are – communicate well, tell the story of your parish life, report back as to how you have allocated the gifts your colleagues have offered and say thank you. Tell them what it was that they made possible. Send receipts out on time. Use commitment and pledge cards. We do it for cable etc, why not for the work of God? I'm appalled with parishes that think pledge cards are beyond the pale. There's no excuse not to make a commitment for the coming year's mission and vision. How else can we budget? We need to challenge our people to be generous financially and with their time.

We need to offer options for giving. The Sunday envelope is very old fashioned. How many of you are paid by an envelope once a week? I went to preauthorized debit, because it does work for a parish. In the first year if you can get 50% of your members to give electronically and offer a weekly as well as a monthly option, giving is up 37% on average. If people start giving in this way, give them a little card they can drop in the plate, so they don't feel left out of a very significant moment in the life of the liturgy. We had a credit card person who sat at the welcoming table inside the door with a card-swiping machine – it works!

Instead of bulk canvas for the annual stewardship campaign, how about small-group gatherings in people's homes, so people have an opportunity to share their dreams and hopes and delight with the work of the parish family, and let the Rector and other leaders communicate? In my Ontario parish one year we had 27 of them. It's exhausting, but it sure works, because it lets people be part of the consultative process, and it's a teaching moment too.

Gift planning is my main focus – and this is a wonderful opportunity for all of us. The theological basis is the parable of the rich fool in Luke 12, - the man who built large barns and wanted to relax, until God said your life is demanded of you tonight, and the things you have prepared, whose will they be? We all have an estate, we all will need to answer that question some day. I heard that 80% of people in Newfoundland didn't have wills, and one man asked me why one was needed. I asked why don't you have wills? He said, it might be because we are going to die. The average in Canada is only 50-60% of adults have wills. This is an opportunity for all of us to do some teaching. If we are to love one another, surely we have the responsibility to help one another be responsible stewards, in looking after our children, disabled people in our family, elderly parents. It's an opportunity for the Anglican Church in our parishes to put forward the question posed in Luke. Aging parents will be passing on to the next generation \$1 trillion in the next decade or so. If churches ask, people will respond. Don' be too shy about giving people the option and opportunity to give from their gifts and assets – it's a wonderful way of making a difference in carrying forward their values and priorities. They can give gifts right away, of listed securities, etc, you don't have to die to be generous. We can solve the capital gains issue too. If you give shares to the church, the tax is 25 per cent, not 50 per cent, and the donation receipt cancels out that tax. Plus you make a very significant difference.

The most import tool is the bequest – most gifts come that way. All you have to do is invite people to consider the possibility of endowing a program or position or ministry or project, or church planting – it's an endless list.

Of the 60 % of Canadians who do not have a will—a survey showed that if they did have a will, 37% said they'd remember their church. So we have a tremendous opportunity. We have Gift Planning consultants in 12 dioceses, including David Connell in Edmonton. We can enter into a partnership agreement with you to give leadership to this priority. I can be a resource person to you. Results over last 11.5 yrs have been \$15 million in gift annuities alone, \$13 million of that given direct for parishes like yours. There are more I don't know about. Annuities cover 5% of planned gifts, and we estimate \$100 million has been raised in bequests in the same time. Most of the money is given direct to specific parishes to ensure their vital ministry continues uninterrupted and can expand. We just have to ask.

Not all donors are wealthy, but everyone has an estate, and everyone has to answer our Lord's question about what it means to be a generous steward. Have a gift planning policy ready for your parish, so that when the widow sends you a bequest, you will know what to do with it. I was discussing the Prayer Works Hall project with a friend called Mary Constance Fraser of Kingston – one of the most generous people I know. She has given a cheque for the Hall, and I present it coupled with one from my own family, to back up the words I have just said.

The Synod recessed for the Eucharist at 9:45 a.m. and reconvened at 11:20 a.m.

#### **ANNOUNCEMENTS:**

Mrs. Barbara Burrows, Secretary of Synod, made announcements regarding the process of balloting and members proceeding to lunch.

#### **BALLOTING:**

The Archbishop led the Synod in a prayer for guidance, and then advised Members to print the name of their selected candidate on the appropriately coloured ballot. He advised that the names of each member of the clergy and each member of the laity will be called by the respective Recorders for the first ballot. For further balloting, members of Synod were asked to place their ballot in the ballot box and be sure the Recorders check their name off. When the outcome of a ballot is ready to be announced, the organist will summon everyone back with a hymn.

#### THE FIRST BALLOT:

The first ballot was called for at 11:35 a.m., and was closed at 11:55 a.m. The Scrutineers retired to count the ballots while the Synod recessed for lunch.

At 1:00 p.m. the Synod reconvened with a hymn and a prayer. The Archbishop reported 89 votes cast by the Clergy (no spoiled ballots), with 45 votes being required for a majority of the clerical votes. - 24. Agreed that the Council of the North Support Grants would be no less than the current level for the next five years (2007-2011 inclusive).
- 25. Gave permission and encouraged the Council of the North to launch collective fund-raising activities to supplement the income received from the Council of the North Support Grants, in full collaboration with the activities of the Office of Financial Development.
- 26. Endorsed the report of the Windsor Report Response Group, as adopted by the Council of General Synod in March 2007, and agreed that the report and the list of the Anglican Church of Canada's commitments be forwarded to the Anglican Communion Office and the Provinces of the Anglican Communion.
- 27. Undertook to provide the necessary resources in stewardship and congregational development to assist all Council of the North dioceses to move as close as possible to self-sufficiency.
- 28. Elected the Rev. Dr. Stephen Andrews as Prolocutor of General Synod.
- 29. Elected Bishop Fred Hiltz as the 13<sup>th</sup> Primate of the Anglican Church of Canada.
- 30. Adopted on *first reading* an amendment to section 6 of the Declaration of Principles.
- 31. Adopted on *first reading* an amendment to section 3 b) of the Declaration of Principles.
- 32. Adopted on *first reading* an amendment to section 6 of the Declaration of Principles by adding the following new clause:
  - s) the appointment, election, confirmation, consecration and resignation of a Bishop Ordinary having jurisdiction over the chaplains of the Anglican Church of Canada on duty with the Canadian Forces.

- 33. Accepted the conclusion of the Primate's Theological Commission's *St. Michael Report* that the blessing of same-sex unions is a matter of doctrine, but is not core doctrine in the sense of being creedal, and should not be a communion-breaking issue.
- 34. Elected Chancellor (Canon) Robert Falby as Deputy Prolocutor of General Synod.
- 35. Defeated a motion to revise the agenda.
- 36. Agreed to move into a Committee of the Whole to discuss the *Blessing of Same Sex Unions*.
- 37. Agreed to rise from the Committee of the Whole.
- 38. Agreed to suspend Rule of Order 23(a) relative to Resolution A185.
- 39. Defeated a motion regarding Voting Requirements for Resolutions A186 and A187, relative to revised Resolution A185.
- 40. Defeated a motion to suspend Rule of Order 18 e) including a request that the votes on Resolution A186 be done by secret ballot.
- 41. Elected the members of the Council of General Synod 2007-2010
- 42. Resolved that the blessing of same-sex unions is not in conflict with the core doctrine (in the sense of being reedal) of The Anglican Church of Canada.
- 43. Defeated a motion to:

Affirm the authority and jurisdiction of any diocesan synod,

- a) with the concurrence of the diocesan Bishop; and
- b) in a manner which respects the conscience of the incumbent and the will of the parish,

to authorize the blessing of committed same sex unions.

- 44. Requested the Council of General Synod to consider a revision of Canon XXI (On Marriage) including theological rationale to allow marriage of all legally qualified persons and to report back to General Synod 2010.
- 45. Welcomed the Statement of the House of Bishops of October, 2006, urging the church to show pastoral understanding and sensitivity to all same-sex couples, including those civilly married, and committing the House to develop pastoral strategies to give effect to the acceptance of gays and lesbians.
- 46. Ratified sections a-d of the proposed constitutional changes for the Anglican Consultative Council, as proposed in ACC-13 Resolution 4; and agreed *not* to ratify ACC-13 Resolution 4, section e) of the proposed constitutional changes for the Anglican Consultative Council.
- 47. Referred to the Council of General Synod for further work, including consultation with the provinces and dioceses of our church, a request that *first reading* be given to amending the Declaration of Principles.

- 48. Referred to the Council of General Synod for further work and consultation a request that *first reading* be given to a resolution amending section 11 of the Declaration of Principles.
- 49. Accepted the *second* report of the Nominating Committee relative to Standing Committees.
- 50. Requested the Primate, after consultation with the House of Bishops, to initiate discussion with the provinces and dioceses of the Anglican Church of Canada regarding:
  - 1) the possible reform of the provincial organization of the Anglican Church of Canada.
  - 2) the possible reform of the diocesan organization of the Anglican Church of Canada.
- 51. Directed the Faith, Worship and Ministry Committee to prepare principles and an agenda for revision of our contemporary language worship texts and the creation of fresh liturgical expressions.
- Requested the General Secretary to write to the Prime Minister, reminding him
  of a previous call from the Anglican Church of Canada on the Government of
  Canada to deliver and implement a plan to reach the UN target of 0.7% of
  Gross National Income for Official Development Assistance by 2015, and
  urgently requesting that budgetary measures be taken toward achieving this
  target.
  - 2. Requested PWRDF and the General Synod through its Partnerships program to:
    - Reconsider how the Millennium Development Goals, in light of the
      attention given them by the wider Anglican Communion at the recent
      TEAM 2007 Conference, can be used effectively to inform and advance the
      global development and advocacy work of PWRDF and General Synod
      throughout the 2007-2010 triennium.
    - Participate as appropriate in the Make Poverty History campaign and the Micah Challenge, national and global movements advocating for the achievement of the Millennium Development Goals by 2015.
    - Explore the possibilities of working in partnership with The Episcopal Church, and with the Evangelical Lutheran Church in Canada to promote the Millennium Development Goals.
  - 3. Requested the Partners in Mission Committee and the Ecojustice Committee (or their successor) and the PWRDF, in consultation with the Faith, Worship and Ministry Committee to:
    - Identify theological themes underlying the eight (8) Millenium Development Goals (MDGs) and the church's response to them.
    - Determine which of the MDGs should be given priority for advocacy and action within Canada.

- Develop, identify and promote educational resources to raise awareness in Anglican dioceses and parishes about the Millennium Development Goals, and about poverty and development issues in Canada using the framework of the MDGs and other Millenium campaign strategies, especially Make Poverty History and The Micah Challenge.
- 53. Approved amendments to the Long Term Disability Plan Pre-2005 Document, as approved by the Council of General Synod.
- 54. Adopted on *second reading* amendments to the Declaration of Principles as follows:
  - 1. by amending section 3 c).
  - 2. by amending subsection 3 f) vi).
- 55. Adopted an amendment to the Constitution of the General Synod as follows:
  - 1. by amending section 8 c).
  - 2. by amending subsection 8 f) vi).
- Committed the Anglican Church of Canada, through its Ecojustice Committee (or its successor), to support the International Campaign to Abolish Nuclear Weapons in its efforts to raise political will for the achievement of a Nuclear Weapons Convention.
  - 2. Requested the Chair of the Ecojustice Committee (or its successor) to direct a letter to ICAN expressing our support for the demands of ICAN.
- 57. Adopted the "Guidelines for Ecumenical Participation in Ordinations" formulated by the Inter-Anglican Standing Commission on Ecumenical Relations and proposed for all churches of the Anglican Communion, as the standard to be generally followed by this Church in all situations in which Anglican bishops and priests are invited to participate in ordinations outside the Anglican Communion, or in which clergy of other churches are invited to participate in Anglican ordinations; and requested all Bishops of the Anglican Church of Canada to follow these Guidelines as the standard for Ecumenical Participation in Ordinations when such questions arise.
- Requested the Primate of the Anglican Church of Canada to write to the Primate of the Episcopal Church in Jerusalem and the Middle East, including the dioceses of Jordan, Lebanon and Syria, of Cyprus and the Gulf, and of Egypt to express:
  - Affirmation of the bonds of fellowship we share as Anglicans with the clergy and people of Jerusalem and the Middle East
  - Solidarity with Anglicans and other Christians in the Province of the Church in Jerusalem and the Middle East in their struggle for justice and peace.
  - Commitment to active prayer and education concerning the condition of the Palestinian people and to advocacy for a peaceful and just solution to the conflict in the region.

- 58. 2. Requested the Ecojustice Committee and Partners in Mission Committee or their successor (in cooperation with Faith Worship and Ministry Committee) to study the policy of ECUSA on the Middle East as a basis for formulating a policy for the Anglican Church of Canada in relation to the Middle East.
  - 3. Requested the Primate of The Anglican Church of Canada to make a solidarity visit to Anglicans and other Christians in Israel and Palestine, and with others seeking peace in the region and, to the extent possible, to extend the visit to other parts of the Middle East, including Jordan, Lebanon, Syria, Cyprus, the Gulf and/or Egypt.
  - 4. Requested the EcoJustice Committee or its successor, in cooperation with KAIROS, to:
    - identify or develop resources for Canadian Anglicans on structural conflict and peace issues in Palestine and Israel
    - equip those travelling to the region and suggest people, organizations and connections in Canada with whom to de-brief upon return.
- 59. Asked the Council of General Synod to convene a taskforce to conduct a detailed study of the role, duties and functions of the Primate.
- 60. Defeated a motion to ban the use of tobacco products.
- 61. In light of the Statement of the House of Bishops to members of General Synod, dated April 30, 2007, General Synod 2007:
  - 1. Asked the Primate to request the Primate's Theological Commission to consult with dioceses and parishes and to report in advance of General Synod 2010 on:
    - the theological question whether the blessing of same-sex unions is a faithful, Spirit-led development of Christian doctrine;
    - Scripture's witness to the integrity of every human person and the question of the sanctity of human relationships.
  - 2. Asked the Primate to request the Anglican Communion Task Force to report in advance of General Synod 2010 on the implications of the blessing of same-sex unions and/or marriage for our church and the Anglican Communion.
  - 3. Supported and encouraged dioceses to offer the most generous pastoral provision possible within the current teaching of the church to gays and lesbians and their families.
  - 4. Requested Faith, Worship and Ministry to develop a process to engage the dioceses and parishes of the Anglican Church of Canada in a study of the Christian perspective of human sexuality through the lens of scripture, reason, tradition and current scientific understanding.
- 62. Forwarded the seventeen remaining motions on the *No Debate List* to the Council of General Synod for consideration.
- 63. Expressed deep appreciation to everyone who contributed to the organization, hosting, leadership, guidance, worship and program of General Synod 2007.
